

2017 Programme Renewal - Information

As in previous years all presenters are required to apply for renewal of their programme for the 2017 calendar year.

The rationale for undertaking this process, which is overseen by the Broadcasting Working Group (BWG), with decisions endorsed by the Committee Of Management (COM), is to ensure that 3WBC is providing an opportunity for:

- presenters to notify the BWG of their programming intentions for the next 12 months.
- presenters to request alternative timeslots for the air time of their programme.
- the BWG/COM to adjust the programming grid to better meet the needs of 3WBC and its audience.

Additionally, presenters are asked to include a brief outline of their program to ensure that its stated purpose is consistent with what is presented on-air.

The CoM and the BWG would like to reiterate that no programme or presenter 'owns' their timeslot. Should you change the format, presenters or content of your programme, it may be deemed a "new" programme and a new application would be required.

Additional notes when completing this form:

- We are asking for **alternate times** as to when you may like to present your programme. This field is not compulsory, but it is suggested that you provide (at least) one additional option. *Failure to do so, may result in your programme not being renewed for 2017.*
- The term "co-ordinator" has been included in the list of presenters. This is for programmes with multiple presenters to provide a key contact for programming discussions.
- The **programme overview** is a short statement that outlines your programme's format and style for the year. (eg: If your programme is scheduled as a news show and becomes a music show half way through the year, it is not meeting its stated purpose).
- All listed presenters need to be certified as "trained" before they can be included. For this renewal period,
 we are using the list to identify those who require training and will contact presenters directly.
